## 7 Services for individual insured persons

These activities are only performed as part of full insurance contracts with the collective foundations of Allianz Suisse Life and are charged to the insured person directly:

-	Processing early withdrawals for home ownership (repayment is free of charge)	Flat fee per case	500.00
-	Processing pledges for home ownership or transfers of home ownership to a new property (cancellation is free of charge)	Flat fee per case	300.00
-	Transfer of foreign vested benefits (clarification and agreement with foreign pension fund including integration of funds)	Flat fee per request and pension fund	200.00

Actual fees, duties and other costs in connection with early withdrawals and pledges (e.g. for the note in the land register) are charged to the insured person additionally.

Changes may be made to this Cost Schedule at any time and are announced three months before they take effect. Apart from the services for individual insured persons, the cost contributions are charged to the premium/contribution account or invoiced to the employer/foundation separately.
